#### **NEW BUSINESS:**

- ✓ Donation request from Family Connections (normally we give them \$600/year) but they did not request it last year. L. Thomas recommended they put their request in this year and we can get it to them by the Fall. D. Engelke motioned to just give it to them now, seconded by D. Martin. Motion carried.
- ✓ Music Boosters: "No Fuss Fundraiser" They asked for a donation, however we donate \$100 every year to them anyway. D. Martin suggest we should if we can, L. Neuheisel suggested we wait until the next budget if we've already sent money out of this year's budget. T. Ellis suggested we should wait until October 1st for this request, and it was

also suggested by H. Crofoot that if we budget for \$200 for Platteville Music Boosters, then we should also increase the contribution to \$200 to Platteville Sports Boosters.

- ✓ Maxine Lane: Jen Richardson, with CESA 3 hard of hearing students, reached out. For some time, we have been looking to be more involved in Optimist's CCDHH. She reached out looking for supporters for covering a deductible for a child without ears who needs a surgery. M. Lane suggested we donate \$500 towards the deductible. L. Neuheisel reminded us that a few years ago someone reached out for help for a child in Cuba City and we decided to keep it to the Platteville area. We will table this decision until after Jen speaks to us on May 21<sup>st</sup>, and after our budget and sales. L. Thomas motioned we could start with \$250 now and then see what we can do when the new budget rolls around. Seconded by H. Crofoot. Motion carried.
- ✓ H. Crofoot announced that he appointed and accepted Fern Nall to be Secretary for 2021-2022.
- ✓ Discussion about by-laws stating that Treasurers can only serve 3-year terms. OI made this by-law for districts and we have used the recommended amount of years, however the financial review each year is in place to catch things like this. Howard suggested to amend the by-laws to allow Duane to continue serving as Treasurer. L. Neuheisel motioned; seconded by L. Thomas. We need to notify the club at our next meeting but can't call for approval until our June meeting. Then Alaina will adjust the bylaws, then submit the amended bylaw to OI for their concurrence.
- ✓ Another by-law states that spouses cannot serve on the board at the same time.
- ✓ Duane will begin including Melissa on the financial reports as she will be attending our meetings for observation.

# GUEST SPEAKER: Matt Ohms, Field Director for Blackhawk Area Council of the Boy Scouts

Matt Ohms directly serves volunteers in Grant Co., Green Co., and Lafayette Co. He began in Janesville and has been serving Southwest Wisconsin & Northwestern Illinois since 2013. Overall, he serves 12 counties. Matt explained that Boy Scouts is not just campfires, but exposing youth to careers, leadership, self-reliance, and life skills. He joked that they "trick kids into learning for fun." In Platteville, there are two Troops: Troup 82 (Methodist Church) and Troop 84 (First English Lutheran Church). In total there are 35 boy scouts. In addition to life skills, they help scouts explore career focuses, hands on experience, mentorship, and career path guidance. The Arrowhead District, serving the Grant Co., Green Co. and Lafayette Co. troops, help the local packs and troops succeed, organize the popcorn sale, guide and train new leaders and raise funding to support the program.

# **GUEST SPEAKER:** Jen Richardson - Audiologist and Deaf/Hard of Hearing teacher. CESA 3 Itinerant Coordinator/DHH

Jen reached out to Maxine who is the District Chair for CCDHH for SWIS District. Jen has 16 years of private practice experience in education audiology. Jen is originally from Bloomington, WI, and moved back to the area 3 years ago with her husband to raise their boys here. She provides services to CESA 3, covering about 30 school districts and traveling up to 200 miles a day going to schools to help students. Locally, she serves 4 kids in the Platteville area and some in Belmont. A lot of her day is utilizing the technology that they work with to communicate. As a private practice, she can also work with parents to guide them with other tools and resources. She showed us some of the technology her students and their parents & teachers can use to communicate to each other including hearing aids, microphones, etc. She also helps kids advocate for themselves, stating the more these kids know they aren't alone, the more empowered they feel.

#### GUEST SPEAKER: Dave Pluym, Eagle Point Solar
