Acceptance is a non-profit organization started by a group of rural community members wanting to help establish therapies, services and support to those living with or serving those with either Sensory Processing Disorders (SPD) or Autism Spectrum Disorders (ASD), in rural southwest Wisconsin. Aiming for Acceptance reaches out and serves all of Southwest Wisconsin. The Learning Center was established to raise awareness and acceptance, provide tools and support for local families, schools, and other organizations in their efforts to assist the Autism community. After hearing Rose in August, Aiming for Acceptance was chosen as the organization to receive funds raised from the silent auction held at the Awards and Installation Banquet. BUSINESS MEETING:

Finance/Administrative: Financial Report: D Borgen updated the members on financials, providing the balance in the internal account, youth account and the joker draw account. Questions from members were responded to with explanation provided. Board recommended approval with second from Kevin Haertzen. Carried.

Proposed 2018-2019 Budget: President Schambow reported that the 2018-2019 budget had been approved by the board for presentment to the membership. She stated additional layers had been added to further identify dollars allocated to the various committees. She also stated that the committee had added a second scholarship provision. Treasurer Borgen reviewed the proposed budget in additional detail, allowing time for questions and answers. The board had recommended approval and second was made by C Clark. Proposed budget approved.

Forms Adoption: Two forms, previously discussed, were presented for approval.

*Donation Request: To be implemented immediately, forwarded to current donation recipients and any new requests. Purpose will be to provide the club with documentation on dollars requested and what the funds will be used for and who will benefit.

*Expense Reimbursement: An internal document, used to itemize and document request for reimbursement when members use personal dollars to purchase items for the club. This will provide further paper trail and support for future audits which are expected per the bylaws. The motion for approval by the board for both forms was seconded by E Engelke. Carried.

Projector and Screen: As acknowledged for some time, the club is in need of both of these items. They have been borrowed for speaker use on several occasions which is proving to be inconvenient. President Schambow has done extensive research; the combined cost for new would be approximately \$670.00. The board had also considered the purchase of used equipment, possibly from The Store at UW-P. The question was not whether to purchase the equipment but rather to use a portion of the excess joker draw funds. The board was recommending the purchase with funds being withdrawn from the joker draw available funds. H Daus seconded, stating considering the speakers we had been having, it was his recommendation to buy high-quality equipment. Following additional discussion, the motion by the board and second by H Daus to utilize joker draw funds to make this purchase was approved. M Lane spoke, reminding the membership we had personally raised \$5,000 for the purchase of the tot slide. We are personally invested in our Optimist Club and further suggested members making personal donations if they chose to. The cost proposed, \$670, would mean approximately \$20 from 30 members. Discussion concluded that we would go forward with the purchase using joker funds, as approved. If any member wanted to make a personal donation they could give it to Duane thus offsetting the amount to be allocated from the joker draw. This would allow for joker draw funds to be available for another charity in the future.
