<u>Program:</u> Ken Kamps introduced Tom Goodney, an expert witness at trials, as our guest speaker. Tom grew up in upstate New York and enjoys making maple syrup, gardening and splitting wood by hand.



Tom was employed by John Deere for many years. He served as a blockman consulting for 42 John Deere dealerships and then as a design engineer. Tom came to John Deere in Dubuque when JD brought the yellow division (construction equipment) to Dubuque in 1969. At that time, he moved to Platteville and raised his family here.

In his later years with John Deere, Tom served as a forensic engineer. He explained that a forensic engineer prepares evidence for public debate. In this field, sticking with the facts, the truth and maintaining credibility are of utmost importance. In this role, Tom investigated

death caused by forestry or agricultural equipment, resolution of insurance claims, product performance issues, and fire involving construction equipment. Tom detailed the steps taken to conduct a thorough investigation.

After taking an early retirement buyout from John Deere, Tom continued to work for the company as an expert witness for trials. This has become his avocation. He has worked in this capacity for not only John Deere, but also Caterpillar, Ford and Massey Ferguson. Tom's work has taken him to 49 out of 50 states with Hawaii being the only exception. He explained that 9 out of 10 cases are resolved without going to trial. He is currently working on 5 cases. Q & A followed.
