**Program:** Thanks to Maxine Lane for organizing our speaker, Dr. Dave Bergmann, Chiropractor with Rosemeyer Jones Chiropractic.

Dr. Bergmann is a native of Platteville and graduated from Platteville High School in 2004. Dr. Bergmann attended the University of Wisconsin-Stevens Point to major in Biology with Chemistry minor. Upon graduation, he attended Logan College of Chiropractic. During his time at Logan, he met his wife, Katelyn, a native of Chesterton, Indiana. Dr. Bergmann graduated Magna Cum Laude in 2011.

Dr. Bergmann worked at Milwaukee Chiropractic Group in Oconomowoc, Wisconsin and Lake Geneva Chiropractic before returning to Platteville where he joined Rosemeyer Jones Chiropractic in 2016. He currently resides in Dodgeville with his wife, who is an Insurance Claims Processor at Southwest Health Center in Platteville, and Max, his 4 ½ month old son.

Dr. Bergmann is an active member of the Wisconsin Chiropractic Association. His Chiropractic techniques include Diversified Technique, Cox Flexion Distraction, Gonstead, and Activator. Dr. Bergmann is also experienced in Graston Technique, Kinesiotaping and Active Release Technique. He is also a Certified Golf Fitness Instructor through the Titleist Performance Institute.

Dr. Bergmann's presentation included a visual, that being spine/vertebrae from a point of being healthy and progressively deteriorating. He explained how this degenerative process occurs over time, eventually resulting in the bone fusing together. If addressed prior to this point, the likelihood of improvement is possible. When it reaches the point that the bones have fused together, the individual is looking at a surgical procedure to defuse the bone structure with hopes of bringing comfort back to their daily life.

Dr. Bergmann stated unique to their office versus other offices in the area is the process of Spinal Decompression. He explained how this process works to open the areas of bone and soft tissue to bring movement and flexibility back into the spinal column. Time was allowed for questions/answers.

Dr. Bergmann is extremely excited to be back in his hometown and working at the clinic he attended as a child for adjustments by Dr. Rosemeyer. He is currently accepting new patients and is looking forward to serving his community.
